

**TERMS AND CONDITIONS ON RENTAL AND USE OF LOCKERS**

WHILE A REASONABLE AMOUNT OF EFFORT IS IN PLACE WITH SECURITY CAMERAS AND VERIFIED ACCESS, LOCKERS ARE NEVER MEANT TO BE A CHEAP FORM OF SECURITY DEPOSIT BOX OR SAFES.

- 1. NO FOOD AND BEVERAGES, PERISHABLES, ANIMALS, LIQUIDS, FLAMMABLES, DANGEROUS ITEMS AND ANY OTHER ITEMS PROHIBITED BY CURRENT LAW, TO BE KEPT IN THE LOCKERS.
- 2. USERS ARE RESPONSIBLE FOR SAFETY OF OWN BELONGINGS. MODETTI PTE. LTD. AND, OR IT'S STAFF MEMBERS ARE NOT LIABLE FOR ANY LOSSES OR DAMAGES TO THE LOCKER CONTENTS.
- 3. PLEASE USE THE COMBINATION PADLOCK PROVIDED. USE OF OWN LOCKS IS PERMITTED, A REFUNDABLE SECURITY DEPOSIT OF S\$50.00 IS APPLICABLE PER PERSONAL LOCK PER LOCKER .
- 4. LOCKERS ARE TO BE LOCKED AT ALL TIMES IN ORDER TO PREVENT UN-AUTHORISED USE. PLEASE CHECK THAT DOOR IS SECURELY CLOSED AND LOCKED BEFORE PUTTING ON THE PADLOCK.
- 5. WHILE WE DO NOT CHARGE ANY FEE FOR RETRIEVING THE SAME CODES EVEN IF YOU FORGOT OR MISPLACE THEM, PLEASE KEEP THE CODES SECURELY. AN ADMIN FEE OF S\$15 IS PAYABLE FOR CHANGING TO A NEW SET OF CODES.
- 6. MODETTI PTE. LTD. RESERVES THE RIGHT TO INSPECT THE LOCKERS AND REMOVE ALL FORMS OF PROHIBITED ITEMS ACCORDINGLY. IF NECESSARY, THE RELEVANT AUTHORITIES WILL BE NOTIFIED.
- 7. USERS MUST NOT MODIFY OR AFFIX ANY ADDITIONAL STRUCTURE OR PARTS TO THE LOCKER. ALL DAMAGES MUST BE REPORTED IMMEDIATELY. NO POSTERS, PAPERS, STICKERS OR OTHER ADHESIVE MATERIALS ARE TO BE PASTED ON THE DOORS OF THE LOCKERS OR THEIR INTERIOR.
- 8. USERS MUST NOTIFY MODETTI PTE. LTD. OF ANY CHANGES OF ADDRESS, CONTACT NUMBER OR PARTICULARS DURING THE RENTAL PERIOD. WE DO NOT MISUSE OR RESELL YOUR PARTICULARS.
- 9. USERS WILL BE GIVEN NOTICE FOR RENEWAL 5 BUSINESS DAYS BEFORE THEIR LOCKER RENTAL EXPIRY DATE, USERS HAVE THE OPTION TO DECIDE WHETHER TO CONTINUE OR DISCONTINUE WITH THE RENTAL.
- 10. THE LOCKER MUST BE CLEARED ON OR BEFORE THE EXPIRY DATE IF YOU DO NOT WISH TO CONTINUE WITH THE RENTAL. OTHERWISE, YOU AGREE THAT YOUR BELONGINGS WILL BE HANDLED AT OUR DISCRETION AND NO CLAIMS WHATSOEVER WILL BE APPLICABLE THEREAFTER.
- 11. LOCKER ARRANGEMENTS ARE ASSIGNED AND ISSUED UPON YOUR REGISTRATION. LOCKER RENTAL COSTS ARE STANDARD NON-REFUNDABLE. ANY PREMATURE TERMINATION OF ANY RENTAL AGREEMENT WILL NOT BE REFUNDED.
- 12. KINDLY NOTE THAT LOCKERS ARE ALLOCATED ON A FIRST COME FIRST SERVED BASIS AND SUBJECT TO AVAILABILITY.
